

Fragrance Oil — CLP Safety Information

Botanical Cast Diffusers · 3ml Dropper Bottle

The following CLP (Classification, Labelling and Packaging) information applies to the fragrance oils supplied with The Foxglove Tree botanical cast diffusers. All oils are IFRA compliant and CLP labelled. Oils are for use with plaster diffusers only — not for skin application, ingestion, or use in food. Keep away from children and pets.

Black Raspberry & Vanilla

(Hexyl Cinnamal, Limonene, Linalool, Linalyl acetate)

Warning: May cause an allergic reaction. Toxic to aquatic life with long lasting effects. If on skin wash with plenty of soap and water. If skin irritation occurs seek medical advice.

Contains: Citral, Ethyl methylphenylglycidate, Tetramethyl acetylocathydronaphthalenes, delta-Damascone. May produce an allergic reaction.

Elderflower & Gooseberry

(Contains: 5,6,7-trimethylocta-2,5-dien-4-on)

Warning: May cause an allergic reaction. Causes serious eye irritation. Harmful to aquatic life with long lasting effects. Avoid release to the environment. If on skin: wash with plenty of soap and water. If in eyes: rinse cautiously with water for several minutes. If skin irritation or rash occurs get medical advice.

Contains: Citronellyl propionate, Geranyl acetate, Linalool, delta-Damascone, Tetramethyl Acetyloctahydronaphthalene.

Honeysuckle & Sandalwood

Warning: May cause an allergic reaction. Harmful to aquatic life with long lasting effects. If on skin wash with plenty of soap and water. If skin irritation occurs seek medical advice.

Contains: (E)-1-(2,6,6-Trimethyl-1,3-Cyclohexadien-1-YL)-2-Buten-1-one, 4-Tert-Butylcyclohexyl acetate, Amyl Cinnamal, Citronellol, Coumarin, Delta-Damascone, Geraniol, Heliotropine, Hexyl Cinnamal, Hexyl Salicylate, Limonene, Linalool, Linalyl Acetate, Tetramethyl Acetyloctahydronaphthalenes. May produce an allergic reaction.

Rhubarb & Rose

Geraniol, Isopropylidenglycerol, Linalool

Warning: May cause an allergic skin reaction. Causes serious eye irritation. Harmful to aquatic life with long lasting effects. Avoid release to the environment. Wear protective gloves/eye protection/face protection. IF ON SKIN: Wash with plenty of soap and water. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If skin irritation or rash occurs: Get medical advice/attention. Dispose of contents/container to approved disposal site, in accordance with local regulations.

Contains: (E)-1-(2,6,6-TRIMETHYL-1,3-CYCLOHEXADIEN-1-YL)-2-BUTEN-1-ONE, ALLYL CYCLOHEXYLPROPIONATE, BENZYL SALICYLATE, CITRAL, CITRONELLOL, DELTA-DAMASCONE, GERANYL ACETATE, HELIOTROPINE, LIMONENE, LINALYL ACETATE, NEROL, NERYL ACETATE, TETRAMETHYL ACETYLOCTAHYDRONAPHTHALENES. May produce an allergic reaction.

Sweet Orange

(Limonene)

Warning: May cause an allergic reaction. Toxic to aquatic life with long lasting effects. If on skin wash with plenty of soap and water. If skin irritation occurs seek medical advice.

Contains: Citral, Isohexenyl Cyclopentenyl, Carbaldehyde, Linalool. May produce an allergic reaction.

Thyme, Olive & Bergamot

(Limonene, Linalool, Linalyl acetate, Tetramethyl acetylocathydronaphthalenes)

Warning: May cause an allergic reaction. Toxic to aquatic life with long lasting effects. If on skin wash with plenty of soap and water. If skin irritation occurs seek medical advice.

Contains: 4-tert-Butylcyclohexyl acetate, Citral, Eucalyptol, Geraniol, Geranyl acetate, Hexyl Cinnamal, beta-Caryophyllene. May produce an allergic reaction.

Warm Linen

(4-Tert-Butylcyclohexyl Acetate, Hexyl Cinnamal, Tetramethyl Acetyloctahydronaphthalenes)

Warning: May cause an allergic skin reaction. Causes serious eye irritation. Toxic to aquatic life with long lasting effects. Avoid release to the environment. If on skin: wash with plenty of soap and water. If in eyes: rinse with water for several minutes. If irritation occurs get medical advice.

Contains: (1S,2R,5S,7R,8R)-8-Methoxy-2,6,6,8-Tetramethyltricyclo[5.3.1.0^{1,5}]Undecane, 3-(2H-1,3-Benzodioxol-5-YL)-2-Methylpropanal, 3-(O&P-Ethylphenyl)-2,2-Dimethylpropionaldehyde, Alpha-Isomethyl Ionone, Hexyl Salicylate, Limonene, Linalyl Acetate. May produce allergic reaction.

General Safety Information
